- 1. I confirm and agree that I voluntarily take part in SPARK RUN ("this Event") entirely at my own risk and responsibility and that I will not hold the Organizer of this Event, sponsors or Organization or persons providing support or services for this Event (including director, employees, agents or contractors, race officials, medical staff, race director, security staff, helpers or volunteers of any of the Event or any person otherwise associated with any of the foregoing) responsible for any death or injuries to any person or for any damage to or loss or destruction of properties or any other economic loss or for any consequential loss, in any such case arising from any accident or mishap or otherwise arising from or connected with this Event, including whether during or before or after this Event, in preparation for it, traveling to or from it or otherwise. I also agree to indemnify or reimburse the Organizer of this Event in respect of any additional expenses or costs incurred by the Organizer of this Event arising from or in connection with my participation in this event. I acknowledge that the Organizer has the sole discretion and reserves the right to cancel the Event at any time without prior notice.
- 2. Upon submitting an entry, I am deemed to have accepted all Terms and Conditions of the Event, the Official Rules as stipulated and also to those that may be later introduced by the Organizer.

#### **Event Cancellation & Refund Policy**

I confirm and agree that:

- 12. The Organizer has the sole discretion and reserves the right to cancel or cut short the Event for any reasons of force majeure or other circumstances beyond the control of the Organizer. Definition of Force Majeure: includes and is not limited to the Organizer being unable to perform its obligations or organize or hold the Event due to fire, flood, earthquake, or other severe natural disaster or act of God; or due to protest, riot, civil disobedience, uprising, march, revolt, assembly, demonstration, occupation, commotion, mass gathering, war, terrorist, insurrection, sabotage, epidemic, pandemic, COVID-19 or other similar contagious disease or government intervention or prohibition or the likelihood of such event or act. There will be no refund of any event fee, charitable donation, and merchandised purchase in any event.
- 13. If the race is forced to be canceled due to weather or any circumstances beyond the
